Terms and Conditions - Game of Chance

- 1) Information on how to enter forms part of the terms and conditions of entry. *Entry into the promotion* is deemed acceptance of these terms and conditions. Headings in this document are included for ease of reference, and do not affect interpretation in any way.
- 2) The promoter is Jetstar Asia Airways Pte Ltd (BRN:200403570D) of Singapore Changi Airport T1, PO Box 323, Singapore 918144, telephone number: 6318 0943. (**Promoter**).

Duration

- 3) All references to time in this document are a reference to the local time in Singapore on the date stated. The promotion commences at 00.01 on 26 June 2017 and closes at 23:59 on 24 July 2017 (**Promotion Period**).

Eligibility to enter

- 4) Entry is open only to citizens and residents of Singapore (**Eligible Entrants**), excluding directors, management, employees and their immediate families of the Promoter and its related bodies corporate and registered travel companions of employees of the Promoter and its related bodies corporate.
- 5) If the prize winner is under the age of 18, before they can redeem their prize they must obtain consent from their parent or legal guardian to do so, and must be accompanied during their prize travel by a Singapore resident over the age of 18.

Entry into the promotion

- 6) To enter, Eligible Entrants must during the Promotion Period:
 - a) Play and complete the games on our microsite <https://flytodarwin.jetstar.com>. Completing the game means successfully submitting the form with all required user particulars. Promoter is not liable for unsuccessful entries resulting from causes not pertaining to the game
 - b) Qualify for more chances if their friends whom they shared the game with, play and complete the games.
 - c) Player will get an additional chance in the draw if the game is completed by a friend through the player's Facebook post which contains a tracking URL.
 - d) A player can only get a maximum of two chances in the draw
- 7) The Promoter is not responsible for any lost, late or misdirected entries.
- 8) The time of entry will be deemed to be the time the entry is received by the Promoter.
- 9) The Promoter reserves the right, at any time, to verify the validity of entries and Eligible Entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

Drawing of entries

- 10) The draw will take place at 11am on 11, 18 and 26 July 2017 at 80 Airport Boulevard #03-81 Changi Airport Terminal 1 Singapore 819642. The draw will be conducted by *the Promoter*. There will be three winners and each winner will be drawn on the above dates.
- 11) The result of the draw is final and no correspondence will be entered into.

The prize

- 12) There will be 3 prizes. The maximum total prize pool value is SGD\$7,500, based on the recommended retail value at the time of printing. The Promoter accepts no responsibility for any variation in the value of the prizes.
- 13) Each prize is 2 return economy tickets to Darwin from Singapore on Jetstar. Prize travel must be booked by 30 September 2017 and travel must be completed by 31 Jan 2018 .
- 14) The prize includes GST and taxes included in the price of the ticket. Unless otherwise stated, the prize does not include travel insurance, passports, visas, meals, taxes not included in the price of the ticket, ground transportation, flights, accommodation or any other costs of a personal nature. Notification of the winner

- 18) The winners will be notified by *email* by 5pm, Thursday 17 August 2017.

Right of the Promoter to redraw

- 19) The Promoter reserves the right to redraw in the event of an entrant being unable to satisfy these promotion terms and conditions or forfeiting or not claiming a prize. For any prize that remains unclaimed at 5pm, 31 August 2017, a second draw will be conducted by the Drawer on 01 September 2017 at the same time and place as the original draw, subject to any written direction given under applicable law. Any winners determined in accordance with clause will be notified by *email* by 06 September 2017.

Limitation of liability and variation of terms

- 20) If any act, omission, event or circumstance occurs which is beyond the reasonable control of the Promoter and which prevents the Promoter from complying with these terms and conditions, the Promoter will not be liable for any failure to perform or delay

in performing its obligations. The Promoter reserves the right (subject to any applicable law) to cancel, terminate or modify or suspend this promotion.

- 21) The Promoter, its related bodies corporate and their respective officers, employees, contractors and agents (**Promotion Parties**) will not be liable for any losses, damages, expenses, costs or personal injuries arising out of this promotion, the promotion of this promotion or the use of any prize, including but not limited to any breach of these terms and conditions, contract or tort (including negligence) and any other common law, equitable or statutory remedy (**Damages**) whatsoever, including but not limited to direct, indirect and consequential Damages, including Damages that cannot reasonably be considered to arise naturally and in the ordinary course of things, even if those Damages were in the contemplation of the Promotion Parties.
- 22) The exclusion of liability in clause 21 does not apply to limit or exclude liability:
- a) for personal injury or death suffered or sustained in connection with the supply of goods or services which are supplied by the Promoter in the ordinary course of business. To remove doubt: third party goods or services, which other than in connection with this promotion, are in the normal course of business supplied by a third party unrelated to the Promotion Parties, are not supplied by the Promoter in the ordinary course of business; and the Promoter's Conditions of Carriage and general booking conditions (and any exclusions contained therein) apply despite any statement to the contrary in these terms and conditions; or
 - b) to the extent it is not permissible at law to limit or exclude liability in the manner contemplated in that clause (in which case that liability is limited to the maximum extent allowable by law).

Entry details and privacy

- 23) Entry details remain the property of the Promoter. The name and photograph of the winner may be used for promotional purposes by the Promoter, unless the winner otherwise notifies the Promoter at the time of accepting the prize. Entrants consent to the Promoter using personal information provided in connection with this promotion for the purposes of facilitating the conduct of the promotion and awarding any prizes (including to *[third parties involved in the promotion/MDSA]* and any applicable statutory authorities) and to conduct marketing activities.
